RE: 2010 Annual Board of Directors Election

TWHBEA

The purpose of this letter is to report the results of the annual election. We mailed 7,085 ballots and postage-paid return envelopes. The U.S. Postal Service returned (36) thirty-six of our mailings as "undeliverable as addressed" and of these we were able to re-mail (5) five. We received 1,795 of our numbered reply envelopes by return mail representing (25.34%). Two hundred and thirty four (234) of the returned ballots abstained from voting. The abstentions include persons not voting at all and persons voting for fewer than the total available (i.e., ballot read vote for 3 and person voted for only 1). Seven (7) were disqualified and not counted due to candidate ineligibility or noncompliance with ballot instructions.


